Fund Objective

The primary investment objective of the fund is to maximise returns over the longer term at the risk of greater short term volatility of capital values.



*Funds in this category are tilted towards a higher equity exposure (both local and international) which could be tantamount to greater fluctuations (volatility) in short-term performances. While statistical analyses of markets' returns indicate that investments in equities (company shares) offer the highest expected returns in the longer-term, it also comes with the highest risk of shortterm capital losses. Most investment returns from these funds are of a capital (rather than income) nature.

Fund Universe

The fund will, apart from assets in liquid form, consist solely of participatory interests in Collective Investment Schemes, investing in equity securities, property shares, property related securities, non-equity securities and money markets instruments.

The investment manager has substantial flexibility to vary the asset allocation in such a manner as he deems appropriate and shall not be precluded from continually varying the exposure to equity securities, nonequity securities and money market portfolios and assets in liquid form to achieve the investment objective of the Fund.

Due to the flexible nature of the fund, no asset allocation limitations apply to this fund.

Commentary

The fund lost -0.58% (after fees) for the quarter. Being high risk and holding most of the exposure in equities, meant that the poor performance in this area took effect. The small listed property, cash and fixed income holdings did well, and the offshore exposure also helped to mute poor performance.



Fixed Income Sector Allocation





Glossary of Terms

Total Investment Charge (TIC) is the sum of the Total Expense Ratio (TER) and the Transaction Costs (TC).

Total Expense Ratio (TER) is the global standard used to measure the impact that the deduction of management and operating costs has on a fund's value. It gives you an indication of the effects these costs have on the future growth of your investment portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Also, the current TER may not necessarily be an accurate indication of future TERs.

Transaction Costs (TC) is a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Calculations are based on actual data where possible and best estimates where actual data is not available.

Std Deviation (Standard Deviation) is a statical measure of the dispersion of returns for a given security or market index.

Max Drawdown is the maximum loss from a peak to a trough of a portfolio, before a new peak is attained. Max drawdown is an indicator of downside risk over a specified time period.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

The fund is registered under the Prime Collective Investment Scheme, managed by Prime Collective Investment Schemes Management Company (RF) (Pty) Ltd ("the manager") (Registration No. 2005/017098/07), a registered Collective Investment Schemes Management Company in terms of the Collective Investment Schemes Control Act 45 of 2002, supervised by the Financial Sector Conduct Authority ('FSCA'). Brantam Financial Services Holdings (Pty) Ltd is the FSCA approved and appointed investment manager of the fund, situated at 12 Montrose Avenue, Craighall Park and authorised as a Financial Services Provider (License No. 544).
