# **Fund Objective**

The primary investment objective of the fund is to achieve enhanced growth of capital over the long term at the risk of moderate short-term volatility of capital values.

Due to the balanced allocation across asset classes within these funds, the investment returns generated will be both of a capital and of an income nature. These funds are suitable for medium to long term investment horizons (5-10 years) and in statistics have a high probability of being able to generate stable inflation beating capital growth over the longer term whilst providing some income distribution.

#### **Fund Universe**

The fund will, apart from assets in liquid form, consist solely of participatory interests in Collective Investment Schemes.

The following asset allocation limitations will apply to the fund:

Equity Funds: 41% to 60%
Property Funds: 0% to 25%
Money Market Funds: 10% to 59%
Fixed Interest Funds: 10% to 59%

The manager will be permitted to invest on behalf of the fund in offshore investments as legislation permits.

## Commentary

The fund gained a welcome 8.11% (after fees) for the quarter. All local sectors of the market recorded gains for the quarter, including bonds, cash rates, listed property and equity exposures. The offshore exposures proved the same and added to the gains for the quarter.







#### **Glossary of Terms**

Total Investment Charge (TIC) is the sum of the Total Expense Ratio (TER) and the Transaction Costs (TC).

Total Expense Ratio (TER) is the global standard used to measure the impact that the deduction of management and operating costs has on a fund's value. It gives you an indication of the effects these costs have on the future growth of your investment portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Also, the current TER may not necessarily be an accurate indication of future TERs.

Transaction Costs (TC) is a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Calculations are based on actual data where possible and best estimates where actual data is not available.

Std Deviation (Standard Deviation) is a statical measure of the dispersion of returns for a given security or market index.

Max Drawdown is the maximum loss from a peak to a trough of a portfolio, before a new peak is attained. Max drawdown is an indicator of downside risk over a specified time period.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

The fund is registered under the Prime Collective Investment Scheme, managed by Prime Collective Investment Schemes Management Company (RF) (Pty) Ltd ("the manager") (Registration No. 2005/017098/07), a registered Collective Investment Schemes Management Company in terms of the Collective Investment Schemes Control Act 45 of 2002, supervised by the Financial Sector Conduct Authority ('FSCA'). Brantam Financial Services Holdings (Pty) Ltd is the FSCA approved and appointed investment manager of the fund, situated at 12 Montrose Avenue, Craighall Park and authorised as a Financial Services Provider (License No. 544).

Collective Investment Schemes ("CIS") in securities are generally medium to long term investments. Dealing prices are calculated on a net asset value and auditor's fees, bank charges and trustee fees are levied against the portfolios. Lump sum investment performances are quoted. Income distributions are in the calculations. The reinvestment of income is calculated on the actual amount distributed per participatory interest by using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. Performance numbers and graphs are sourced from Morningstar. NAV to NAV figures have been used. A fund of funds is a portfolio that invests in portfolios of collective investment schemes that levy their own charges, which could result in a higher fee structure for the fund of
